

## 2024 INFINZ Conference Scholarship Eligibility and application details

INFINZ is holding its [2024 Conference](#) on 15 October 2024 at the Cordis Hotel, 83 Symonds Street, Auckland and wishes to provide 10 scholarships for students to attend free of charge.

The INFINZ Conference Scholarships will be awarded on the basis of applications made which will be assessed by a selection panel and interviews may be held.

### Application criteria:

- Previous INFINZ Scholars are not eligible
- Only available to INFINZ members - students are charged an annual processing fee of \$30 including gst (or \$20 including gst if a member of a relevant student club) - please contact Iona Gibbs, [admin@infinz.com](mailto:admin@infinz.com) or go to [www.infinz.com](http://www.infinz.com) for more details)
- Those students in full-time study at one of the following Universities; Auckland, AUT, Canterbury, Lincoln, Massey, Otago, Victoria or Waikato
- Preference will be given to those students in the final year of undergraduate study or in post-graduate study
- Study programs include all commerce-related subjects such as economics, finance, accounting, entrepreneurship and commercial law
- Grades B+ and above
- Demonstrated leadership capability, including in student clubs or NFPs
- Those best able to articulate the benefit of attending the INFINZ Conference for their professional development
- The applications must be supported by their respective Business school/faculty
- A non-academic referee must be provided who can speak to the non-academic achievements

### The scholarship will comprise:

- Conference registration is free for scholars. You must be an INFINZ member. The standard member-rate otherwise available is \$970 including gst. (NB: The scholarship does not cover travel or accommodation expenses).
- Brief profile in INFINZ electronic newsletter which goes to our database of over 5000 recipients and for inclusion on INFINZ website. These profiles will also be included in the Conference program which will be made available to all delegates.
- Able to note on their CV that they were selected for the (2024) INFINZ Conference Scholarship.
- A lunchtime meeting will be separately arranged with the Executive Director and some of the INFINZ Board members to further your network and connections.

### Obligations for scholarship holders:

- Must uphold the standards expected of members and act as excellent role models
- Willingness to report back to fellow students on the findings/learnings from the Conference
- Willingness to provide feedback regards their experience to INFINZ and to fellow students

### Process/timeframes

- Applications must be made by **2 August** and emailed to the INFINZ Administration Manager Iona Gibbs, [admin@infinz.com](mailto:admin@infinz.com)
- Selection by 2 September and all applicants advised
